

The Reproductive Privacy Act of 1991 guarantees patients the right to make their own reproductive health decisions confidentially.

Overview of the Reproductive Privacy Act (RPA) of 1991

Key Provisions of the RPA Include:

Patient Autonomy: Patients have the absolute right to make decisions about their reproductive health without interference.

Confidentiality: All patient information regarding reproductive health must be kept confidential.

Non-Discrimination: No patient should face discrimination based on their reproductive health choices.

Does Summit Pacific offer maternity delivery services?

Summit Pacific Medical Center provides prenatal and post-delivery outpatient care through its family medicine physicians for patients established with its primary care providers.

Many of our family physicians offer continuity maternity services. These physicians will provide prenatal care in our clinics and will also be there for you during delivery at nearby hospitals.

Current primary care patients can schedule appointments by calling 360-346-2223, while those interested in establishing care for women's reproductive services should call 360-495-5775.

Does Summit Pacific offer termination services?

Medical termination is available to patients established with a Summit Pacific primary care provider if the pregnancy is less than 10 weeks (70 days).

Self-referral to Planned Parenthood or Washington Reproductive Access Alliance (WRAA) may be faster for those over six weeks pregnant. Virtual services are available via WRAA and the University of Washington.

Surgical termination is not available at Summit Pacific. Patients are advised to contact WRAA or regional facilities for these services. Please refer to the back panel for phone numbers.

Current primary care patients and those interested in pregnancy management can call 360-495-5775 to schedule appointments.





How does the Reproductive Privacy Act (RPA) Affect Summit Pacific's Services?

The Reproductive Privacy Act, passed by the Washington Legislature in 1991, requires public hospitals providing maternity care to also offer comparable termination services. Summit Pacific is a Public Hospital District in Washington State and must comply with the RPA.

Summit Pacific Medical Center provides prenatal and post-delivery outpatient carethrough its family medicine physicians but does
not provide labor and delivery services.

Since Summit does not have a Labor and Delivery Department or surgical suites, **Summit does not offer surgical terminations**.

Patients seeking surgical termination of pregnancy are encouraged to contact the Washington Reproductive Access Alliance at (206) 597-0040, or Planned Parenthood at (800) 769-0045. The Alliance is operated by the University of Washington.
